**Agreement**

This agreement is between **TEAM WASHINGTON, INC.** (“Domino’s”) an independent Domino’s Pizza® (“Franchisee”) and the above “Fund raiser”.

Domino’s hereby sells to Fund Raiser the above quantity of Fund Raising cards at a price of \$1 per card. Fund Raiser acknowledges receipt of cards. Payment is due prior to or upon receipt of the cards. Fund Raiser agrees to sell the cards individually to the general public for no more than the face value of each card. The cards shall not be resold in bulk via Ebay, Craigslist, Amazon or any other online retail site or social networking site. Fund-raiser agrees that it shall be solely responsible for the safety of those involved with Fund-raiser in its sale of the Cards and/or other provisions of this Agreement regarding the sale of the Cards. Sales of the Cards by Fund-raiser are transactions between Fund-raiser and the relevant buyer(s), and Fund-raiser remains solely responsible for delivery of Cards and collection of amounts owed to Fund-raiser by buyers. Fund-raiser shall be solely responsible for any and all claims related to its participation in this program and agrees to defend and indemnify Franchisee and its franchisor from all such claims. Fund-raiser represents and warrants that (i) it is, and at all times during the term of this Agreement will remain, a Tax-Deductible Organization with public charity status described in section 170(c) of the Internal Revenue Code; (ii) it will utilize proceeds received through the sale of the Cards in accordance with such tax-exempt status; (iii) it will undertake any and all actions necessary to comply with any applicable laws, rules and regulations, including, without limitation, any requirements governing solicitation of charitable donations and registration requirements, if any, related to activities contemplated by the sale of the Cards; and (iv) it has read and accepts the Terms and Conditions at [www.dominos.com](http://www.dominos.com). Fund-raiser may not assign this Agreement.

Other than the right to sell the Cards according to this Agreement, Fund-raiser has no other right to use the Domino’s logo or marks. Fund-raiser recognizes that the offers on the Cards are available at participating Domino’s Pizza locations only, are not valid with any other offer or special, and only one offer may be redeemed per order. Fund-raiser will use its best efforts to accurately portray the offer when selling the Cards and agrees not to include any false, misleading, defamatory, obscene or illegal statement. This Agreement applies only to the quantity of Cards set out above and a new Agreement must be entered into if additional Cards are subsequently ordered. Franchisee may terminate this Agreement if Fund-raiser violates any of its provisions and in that event Fund-raiser must cease selling the Cards. This Agreement and the Terms and Conditions at [www.dominos.com](http://www.dominos.com), as they may be modified from time to time, constitute the entire agreement concerning Fund-raiser’s participation in the Domino’s Pizza Fund-raising Card Program.
